12. Financial Assistance for encouraging production of Traditional Khell-Tiatr

Khell-Tiatr is a folk musical drama of Goa. There is an urgent need to preserve this folk drama. In order to encourage dramatic troupes/individual to produce Khell-Tiatrs of better quality, TAG has formulated this Scheme.

The norms of this scheme are:-

1. The scheme will be applicable to any Dramatic Troupes/individual producing Khell-Tiatrs provided they fulfill the conditions laid down in the scheme.
2. The Khell-Tiatr produced should be a new/old script conforming to the traditional format of the Khell-Tiatr. The traditional format is as under:-
 - **A Khell-Tiatr is one in which just one story flows from beginning to end with an interval of 10-15 minutes in between. A Khell-Tiatr has 12 to 14 cantos which are related to the theme of the play. Out of these at least 7 cantos should be of interactive nature.**
 - **The band should include at least two blowing instruments, one keyboard, one bass guitar and a drum set.**
3. There should not be any adverse remark made in any form either written or verbal against any Government/Individual/Institution, etc. or anything against one's caste, creed and religion which may lead to hurting of religious sentiments of anybody. If proved so, TAG reserves the right to disqualify the performance and refrain from making any payment or recall the payment if already made to the concerned.
4. TAG will give support or compensate the expenditure (as fixed by TAG) as financial assistance for staging 4 shows besides providing an auditorium/hall to stage the programme. In case the programme is in village, then TAG will provide financial assistance (as fixed by TAG) for erecting a temporary pandal/stage, chairs, sound, etc.
5. In order to preserve the presentation of Khell-tiatr for future generations, TAG will video film the said khell-tiatr for its Library and other uses. One copy of the DVD will be given to the applicant free of cost. The videographer will be appointed by TAG. The troupe will have freedom to use the DVD in any manner. However, the dramatic troupe cannot make use of the logo of TAG of the said DVD.
6. All shows must be shown to the public free of charge.
7. TAG has no objection if some sponsorship is taken by the producer from other sources.
8. The producer will have to give the proposal at least 30 days in advance giving all details of the programme i.e. typed copy of script and lyrics to be presented including the names of the artistes.
9. The organizing institution/individual will have to comply with the following conditions:-
 - a. In all advertisements, oral, print or electronic media, banners, etc. the following must be inserted/published/announced **'This programme is held in collaboration with Tiatr Academy of Goa'**.
 - b. A statement of expenditure enclosing all original bills (stamped receipt if amount exceeds Rs.5000/-) should be submitted to TAG. The payment will be made directly to the applicant.
 - c. 5 copies of photographs of the function must be sent to TAG for records, two of which should show the TAG's banner during performance.
 - d. The duration of the khell-tiatr should be not less than two hours excluding interval.

- e. The organizing dramatic troupe/individual will have to discuss with TAG and decide about the Chief Guest/Guest of Honor well in advance. The President or Vice President of TAG will be the Chief Guest/Guest of Honour at the function.
10. The concerned who wants to avail the benefit of this scheme shall submit self-attested copies of Aadhaar and PAN Card along with the application.
11. TAG reserves the right to make any changes in the rules.
