# 38. Financial Assistance to Commercial Tiatr Troupes/Directors/Producers for Stage Setting

In order to encourage all round development of the Tiatr in all aspects TAG is of the opinion that encouragement should be given to commercial tiatr directors and producers to bring in development also in stage setting. Keeping this in mind TAG has devised this scheme.

#### The norms of this scheme are:-

- 1. Applications will be invited by announcing the scheme in the local dailies by way of advertisement, press release, internet, etc.
- 2. In all six commercial tiatr troupes/directors/producers will be provided with a financial assistance as fixed by TAG.
- 3. If there are more than six applicants than the six applicants will be decided by way of lots. The remaining applicants will be wait listed and will be provided with the financial assistance in the following financial year.
- 4. To be eligible for this scheme, the applicant has to be on the commercial tiatr stage for at least five years. A proof of the same should be produced along with the application
- 5. In case of withdrawal by any of the applicant from the scheme the next applicant on the list will be given the preference for allotment.
- 6. The applicant availing the benefit under this scheme will not be entitled to avail the benefit again under this scheme for the next five years from the date of receiving the financial assistance.
- 7. Logo of Tiatr Academy should be displayed on the front visible frames of the stage set.
- 8. The set designed under this scheme will not be permitted to be given on hire. Also there should not be any adverse remarks against any individual/government/political parties, etc. during the use of this set.
- 9. Payment shall be made only on completion of 15 performances of the tiatr mentioned in the application. A proof (booking receipts/tickets/advertisement/certificate from organizers/etc.) of the same should be submitted along with the claim.
- 10. The applicant should commence the work on the stage set only after getting a written approval from TAG.
- 11. The interested individuals/associations/dramatic troupes/educational institutions will have to submit the prescribed application form along with one typed copy of the script of the tiatr.
- 12. The applicant will have to submit self-attested copies of PAN Card and Aadhaar Card to TAG failing which TAG will not disburse any claims.
- 13. The Tiatr Academy of Goa reserves the right to make any changes in the rules.
