#### 9. Promotion of Tiatr Music

TAG has observed that the number of musicians playing blowing instruments such as Trumpet and Saxophone is decreasing day by day and that these two instruments are very important for the music of Tiatr. In view of this, TAG has formulated a scheme to encourage youth and others to learn to play blowing instruments particularly Trumpet and Saxophone by providing them with financial assistance.

#### The norms of this scheme are:-

- 1. Any interested person, young or adult, is free to avail the benefit of this scheme subject to Rule 9 (below) of this Scheme.
- 2. The interested person will have to identify a tutor having the credentials to teach him/her the blowing instrument. TAG will accept the tutor after verifying his/her credentials.
- 3. The tuition fees to be paid to the tutor will be decided by TAG.
- 4. The tutor should maintain a record of attendance of the students and submit the same to TAG.
- 5. The blowing instrument (Saxophone/Trumpet/Clarinet) will have to be first purchased by the student and 50% of the cost of the instrument (Subsidy) will be refunded to the student on completion of the full course. The instrument being purchased should be of medium price (neither of lesser cost nor of higher cost). Same may be purchased in consultation or on recommendation of the Music Teacher who is in a better position to identify the brand/make of the instrument. The student can purchase the instrument of higher cost, but TAG will take into consideration the value of medium priced instrument only. Once purchased, a self-attested Xerox copy of the bill of the instrument purchased must be submitted to the TAG immediately. The original bill will have to be preserved by the student, which he/she will have to submit to TAG upon completion of the Course in all respects, in order to claim 50% Subsidy of the cost of the instrument, which TAG will refund to the student subject to availability of funds.
- 6. The student will have the choice to either choose the instrument approved by TAG or can even opt for an instrument of lesser/higher cost. TAG will bear only 50% of the approved rate as above or less as the case may be.
- 7. The student will have to give an undertaking to TAG that he/she will serve the tiatr stage by playing in any tiatr band or musical group for at least one year after completion of the course.
- 8. TAG may also conduct music classes for blowing instruments at TAG's Conference Hall by appointing tutors having the credentials to teach these instruments.
- 9. TAG will finalize the names of the applicants based on the merit report submitted by the tutor.
- 10. TAG will appoint a panel of expert musicians in the field to frame the syllabus of the course under the scheme. This panel will also examine the progress of the students learning music.
- 11. Preference will be given to applicants having knowledge of music.
- 12. The scheme will be implemented on 'First Come First Serve' basis and applications will be considered as per the availability of funds. The students will be awarded certificates upon the successful completion of the course. The duration of the course will be at two levels and will be spread over a period of 2 years or else as finalized by the panel of experts as the need may be.
- 13. The students will undergo periodical tests to verify their performance. Those students, who cannot cope up with the syllabus or are found not serious in

- learning, will be terminated from continuing under this scheme after proper evaluation report from the expert panel.
- 14. TAG shall encourage such students to register and get themselves certified by institutions such as Trinity College or Royal School of Music through appropriate financial support.
- 15. Interested persons may apply in the prescribed application form available in the office of TAG.
- 16. The concerned who wants to avail the benefit of this scheme shall submit self-attested copies of Aadhaar and PAN Card along with the application.
- 17. TAG reserves the right to make any changes in the rules.
