36. Young Achievers Awards

There are young talented artistes who have contributed and still continue to work for the development of tiatr, its song and music, and some of them have enriched Konkani Tiatr and Song through All India Radio, Doordarshan and other platforms at national and international levels. This scheme has been devised in order to recognize their achievements in the field.

The norms of the scheme are:-

- 1. The artistes selected to be conferred Young Achievers Award should be not more than 35 years of age as on 16/11/2025. The age limit may be relaxed if the health of the artiste is not well
- 2. The award will be given to 2 male and 2 female artistes every year.
- 3. His/Her selection should be done by considering not only years of service to the cause of tiatr, but, following aspects should also be taken into consideration at the time of selection:
 - a) Applicant's contribution as an actor, script writer, director, singer, lyricist, set designer, etc.
 - b) Whether he/she received/won any awards in his/her field.
 - c) Whether he/she has done any innovation on the tiatr stage.
 - d) If a singer/musician, are there any of his/her songs recorded on CDs, DVDs, AIR, Doordarshan, online, etc.
 - e) Besides tiatr, has he/she acted/directed/sung/composed music/ composed lyrics/designed sets/provided background music/designed light effects, etc. for dramas in other languages or in films.
 - f) If script writer or lyricist, has he/she published any books of his/her scripts/lyrics.
 - g) If a writer/director, he/she should have written/directed at least 5 tiatrs.
 - h) His/her contribution in the field of tiatr i.e. acting/singing/providing live music/stage setting/background music, providing lights, as a makeup artiste should be at least for 5 years and should have performed in at least 8 tiatrs.
- 4. Selection for Young Achievers award will be done on the criteria stated above through recommendation from individuals/institutions. However, the Executive Board may also select the deserving artistes from outside the recommended list.
- 5. The selected artistes who will have to be compulsorily present in person to receive the award, will be honoured at a special function on 16th November on the occasion of the Birth Anniversary of Regina Fernandes the First Lady of the Tiatr Stage.
- 6. The Young Achievers Award will consist of a memento, a Citation and Cash burse of Rs. 20,000/-.
- 7. The last date to submit the duly filled application form along with documentary evidence i.e. photocopies of birth certificate, election card, passport copy, citations, certificates, photos of performances etc. alongwith photocopy of passbook/cancelled cheque, Aadhar Card is 30th September 2025 during office hours.
