## 11. Financial Assistance to Dramatic Troupes participating in Kala Academy's Annual Tiatr Competition

This scheme has been formulated by TAG in order to encourage non-commercial dramatic troupes participating in Kala Academy's yearly Tiatr Festival to produce tiatrs of better quality, TAG has formulated this Scheme.

### The Rules and Regulations of this scheme are:-

1. The scheme will be applicable to the Dramatic Troupes participating in the Tiatr Competitions organized by Kala Academy provided they fulfill the conditions laid down in the scheme.
2. (a) The tiatr should be produced in its original format. This format includes 6 or 7 acts (podd'dde) with at least 4 'cantos' and comedy linked to the story of the play.  
(b) Besides it must have at least 10 'Kantaram' which should include at least 2 Duets, 1 Duo, 1 Trio, 1 Quartet/Quintet, 1 Choral Song and Solos.
3. **Interested Dramatic Troupes may apply in the prescribed application form available in the office of TAG, 5 days before their performance.** One typed copy of the Tiatr script and one typed copy each of the lyrics of the songs must be submitted to TAG alongwith the application form (Handwritten copy of script and lyrics will not be accepted).
4. There should not be any adverse remark made in any form either written or verbal against any Government/Individual/Institution, etc. or anything against one's caste, creed and religion which may lead to hurting of religious sentiments of anybody. If proved so, TAG reserves the right to disqualify the performance and refrain from making any payment or recall the payment if already made to the concerned.
5. TAG will collaborate with the participating troupes and financially support them to the extent as fixed by TAG, in the following aspects of drama, i.e. :-
  - (i) Direction
  - (ii) Stage Setting
  - (iii) Live Band Music with at least 2 blowing instruments.
  - (iv) Light Effects
  - (v) Background Music
  - (vi) Costumes
  - (vii) Make-up
  - (viii) Transport

This financial support is for the purpose of improving the above aspect of Tiatr. The original bills along with a statement of expenditure will have to be submitted to TAG by the **institution within 15 days of their performance during office hours. Kindly ensure bills are submitted on time, as late submissions may not be processed.** The bills to the extent of amount fixed by TAG for the above services will be paid directly to the **institution**. The service providers will have to acknowledge the payments with the receipts (stamped receipts for amount exceeding Rs.5000/-).

6. In order to preserve the presentation of tiatr for future generations, TAG will video record the said tiatr for its Library and other uses.
7. Due announcement should be made before the performance that **'This Tiatr is staged in collaboration with Tiatr Academy of Goa'**.

8. If publicity of the tiatr show is made through advertisements, oral, print or electronic media, banners/standees or social media etc. the following must be inserted/published that **'This Tiatr is staged in collaboration with Tiatr Academy of Goa'**.
9. When the benefit of this scheme is availed by the dramatic troupe for a particular tiatr, the said tiatr will not be allowed to take benefit of the scheme "Production of Tiatr in Villages/ urban areas/ Educational Institutes".
10. Those participating troupes which cannot score 40% of marks in respect of Group A and 35% of marks in respect of Group B for overall performance in the competition will not be considered for availing the benefits of this scheme for next competition.
11. **TAG will appoint an observer to check that the tiatr is performed as per traditional format.**
12. **The concerned who wants to avail the benefit of this scheme shall submit PAN Card of the institution and self-attested copy of Election Card of President and Secretary of the institution along with the application.**
13. Foreign nationals will not be able to avail the benefit of this scheme.
14. TAG reserves the right to make any changes in the rules.
